REGISTRATION FOR ROLLING STOCK VENDOR

The Kuching Urban Transportation System (KUTS) is envisioned to be the backbone of the public transport system for Greater Kuching in minimising and alleviating traffic congestions and at the same time spurring greater productivity as well as economic opportunities. At the heart of the KUTS is the Automated Rapid Transit (ART) that will provide a reliable, sustainable and modern public transportation system for Greater Kuching.

Sarawak Metro Sdn Bhd (Sarawak Metro) has been entrusted by the Sarawak Government to transform the public road transport system in major urban areas. As a wholly-owned subsidiary of Sarawak Economic Development Corporation (SEDC), Sarawak Metro's aim is to provide urban commuters a safe and reliable mode of travel that is also more convenient, comfortable and environmentally-friendly.

The intent of this registration for Rolling Stock Vendor is to identify vendors which will subsequently be invited to submit competitive tenders for Rolling Stock as stated in the table below.

SARAWAK METRO SDN BHD (Sarawak Metro) wishes to invite prospective vendors to registers as Rolling Stock Vendor with Sarawak Metro by submitting a duly completed Vendor Registration Form with supporting information and documents. All applications shall be made by the Company or Firm with the following criteria and duly signed by an authorized officer;

- a) Malaysian company or companies with relevant railway-related experience
- b) Foreign-owned locally-incorporated company or companies in joint venture with Malaysian company or companies
- c) For eign company or companies in joint venture with Malaysian company or companies
- d) A Joint Venture or Consortium must not exceed three (3) individual companies. This is subject to each company not being made up already of a Joint venture Company

Vendor Registration Forms can be downloaded from Sarawak Metro's website at www.mysarawakmetro.com and it is the Vendor's responsibility to ensure all submissions are complete, with the necessary supporting documents duly attached. Incomplete submissions and inadequate information could delay and result in inability to process the Vendors' registration.
